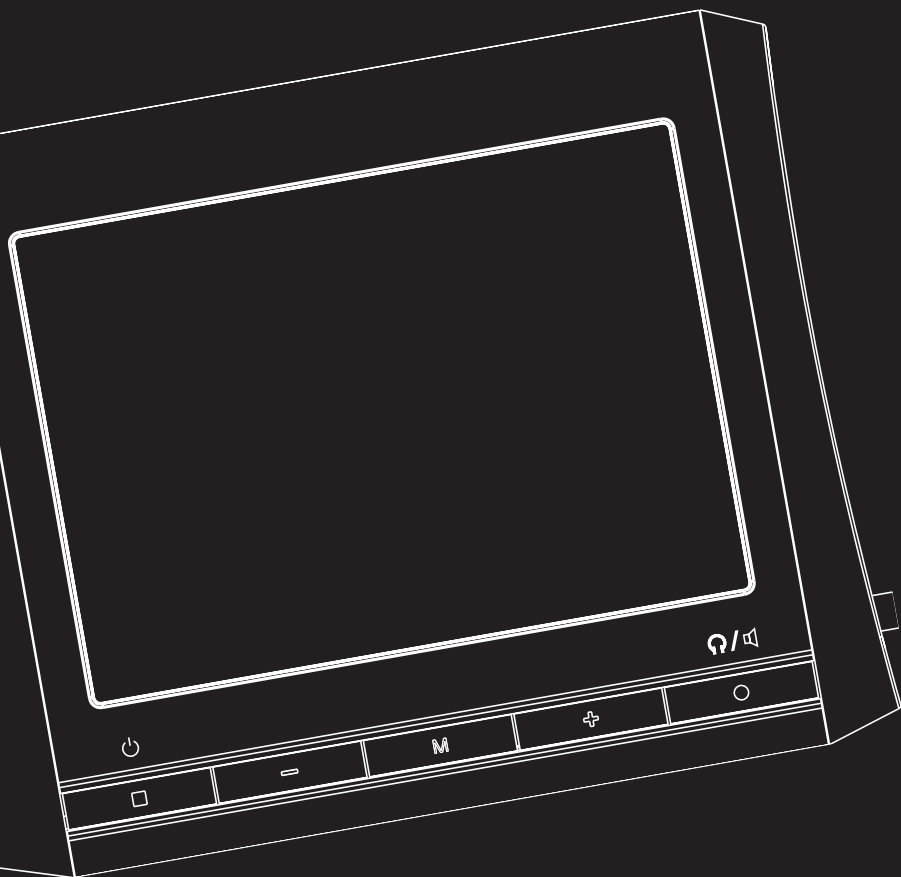

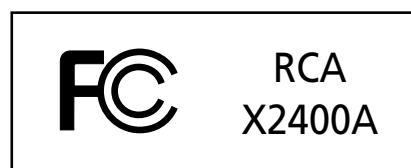

This player is meant to play MPEG4 video and mp3 files.

To do so, you need the use of a Windows computer with USB port , USB cable (included) and Video management software.

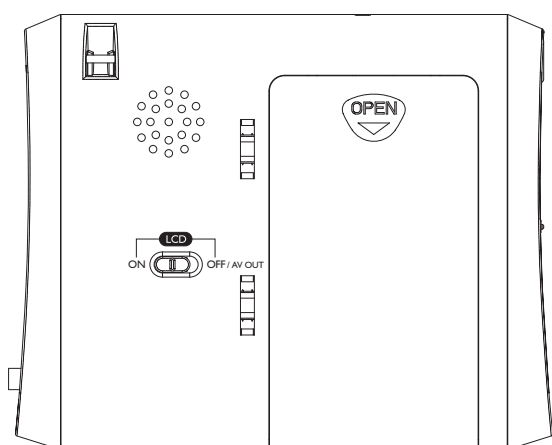

Inserting battery into the player

1. Remove the battery door by applying thumb pressure. Slide the battery door in the direction of the arrow, then lift the battery door out and off the cabinet.



2. Insert the Lithium polymer rechargeable battery. Insure that the contacts of the battery line up with the contacts of the player. (Refer to "Important information" for important battery information.)
3. Close the door of the battery compartment.

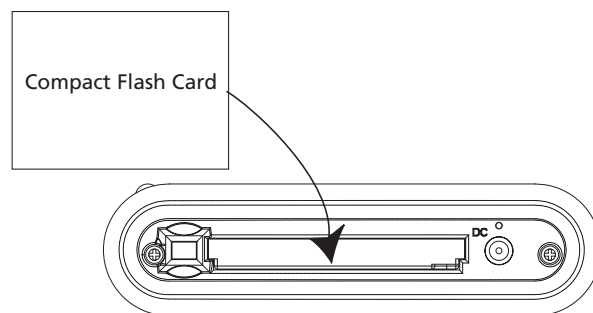

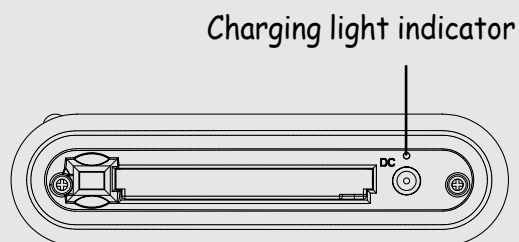
The charging light indicator changes from red to blue when the battery is fully charged.

Inserting a Compact Flash Card

1. Turn off the unit. Insert a Compact Flash Card with the label side down into the card slot on the right side of the player as illustrated in the diagram below.



2. To remove the card, push the button beside the slot twice to eject the compact flash card.

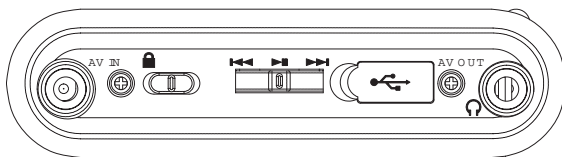
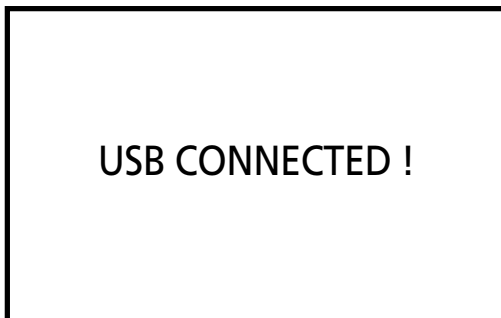

Connecting the Player to your computer

1. Lift the cover that is covering the USB port on the player.
2. Insert the smaller end of the USB cable to the USB port on the player.
3. Connect the larger end of the cable to the USB port on the computer tightly.
4. This screen will appear on the display of the player.

Refer to the Software Instruction manual for procedures in setting up USB drivers and transferring files to the player.

Images and video need to be converted by the bundled video management software before browsing in the player.

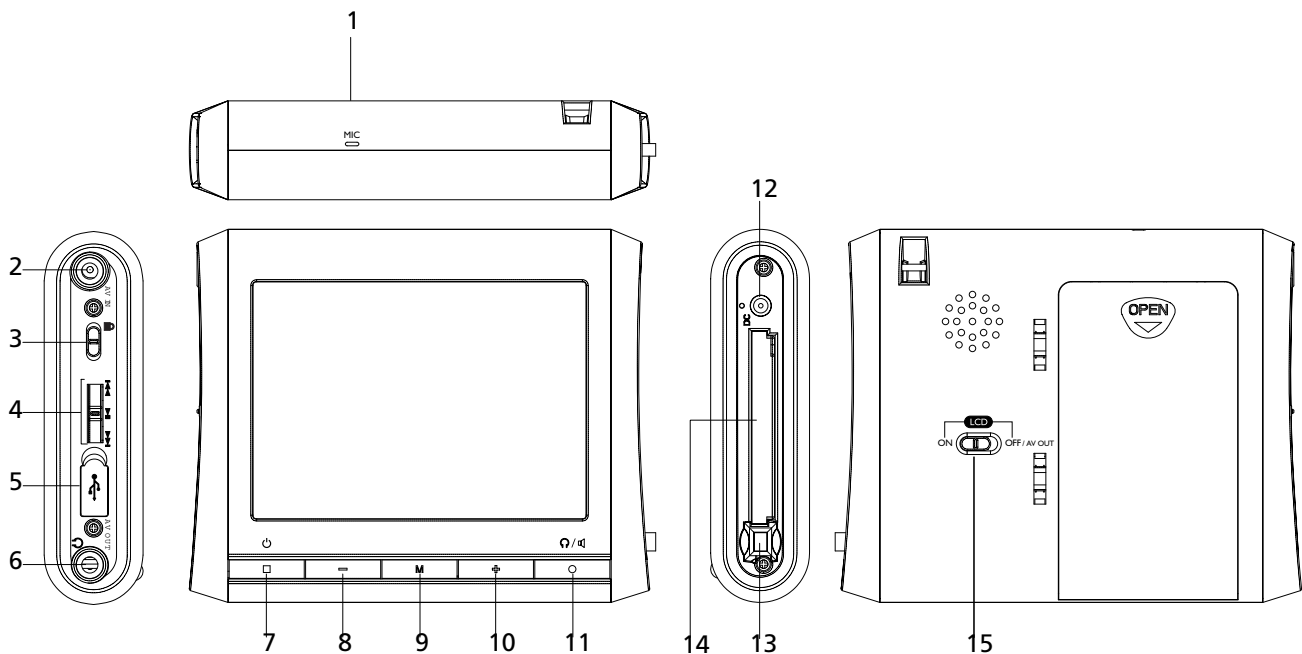

Make sure audio tracks are encoded in the mp3 formats at supported bitrates. Bitrates supported by the player: mp3 - 32 to 320 kbps. WMA and DRM formats are not supported.

1. Mic - Records voice in voice recording mode.

2. AV IN (Black)- Input audio and video signal when the audio and video cable is connected.

3. Lock - Slide to lock or unlock the keys of the player.

4. Playback speed controls

• **In video playback mode:**

- slide down ►► to toggle the playback speed among 1x, 2x, 4x, 8x and 20x
- slide up ◀◀ to toggle the reverse playback speed among 1x, 2x, 4x, 8x and 20x.
- press in ►|| to start and pause playback.

• **In audio playback mode:**

- slide down ►► to go to the next track and press in ►|| to start playback.
- slide up ◀◀ to go to previous track and press in ►|| to start playback.
- slide down and hold ►► to fast forward the track.
- slide up and hold ◀◀ to review the track.
- press in ►|| to start and pause playback.

• **When browsing photos:**

- slide down ►► to go to the next file
- slide up ◀◀ to go to the previous file.

• **In menu mode:**

- slide down ►► to go to the next option
- slide up ◀◀ to go to the previous option
- press in ►|| to select option.

• **In AV recording mode:**

- press in ►|| to turn off or on the speaker.





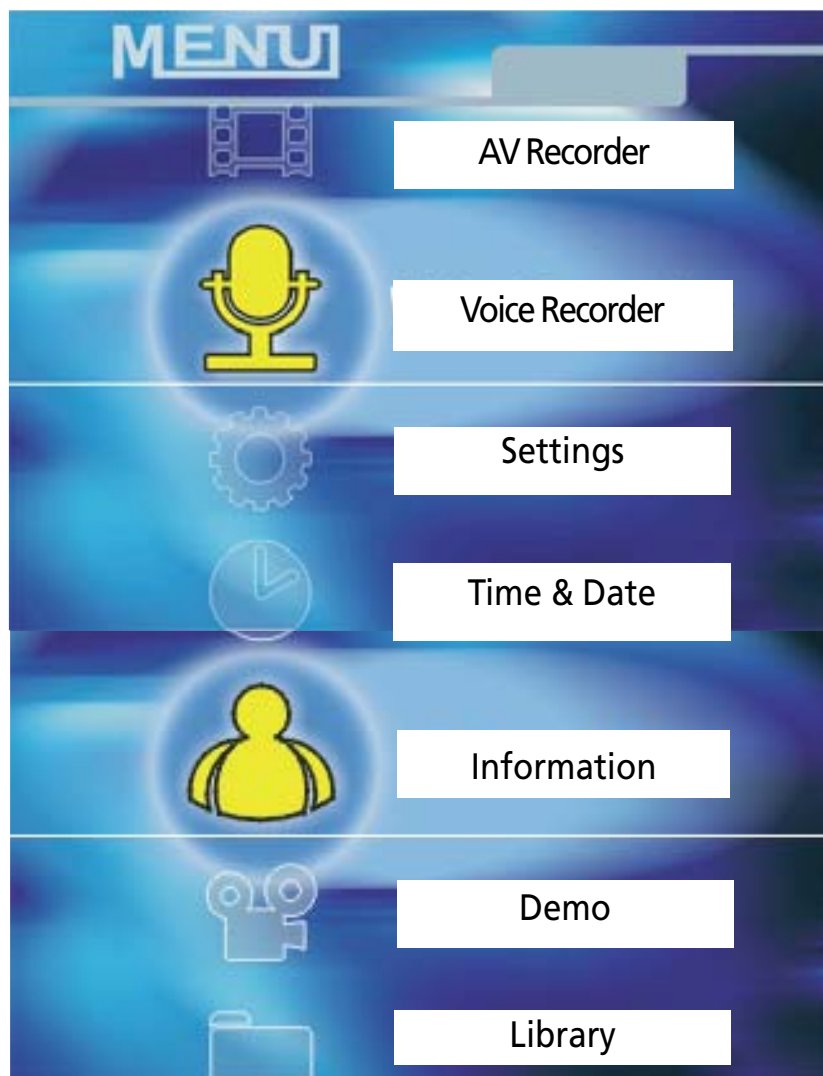

Press and hold  to turn the unit on.

Slide down  or slide up  to view options and press in  to enter a sub-menu. To exit menu, press .

In menu mode, slide down ►► or slide up ◀◀ to view options. Select Library option by pressing in ►■.

Select this option to play video, mp3 and wave files and browse images.

Playback audio and video files

Selecting Files

Slide down ►► or slide up ◀◀ to select the audio or video file you want to play. Press + to go to the next page and - to go to the previous page.

Playback Controls

Play / pause

- Press in ►■ to begin playback.
- Press in ►■ once to pause playback, press again to resume playback.

Stop

- Press □/⏻ to stop playback.

Skipping files

- In audio playback mode, slide down ►► to go to the next track.
- In audio playback mode, slide up ◀◀ to go to the previous track.

Scanning files

- In video playback mode, slide down ►► to toggle the playback speed among 1x, 2x, 4x, 8x and 20x and slide up ◀◀ to toggle the reverse playback speed among 1x, 2x, 4x, 8x and 20x
- In audio playback mode, slide down and hold ►► to scan forward.
- In audio playback mode, slide up and hold ◀◀ to scan backward.

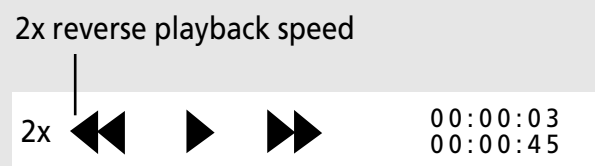
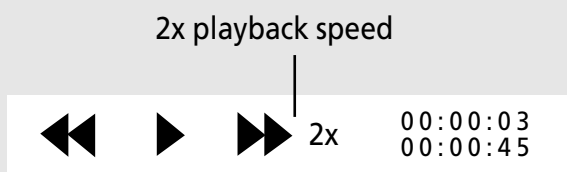

Switching Audio Output

Switching Video Output

- Connect the black end of audio and video cable to headphones jack and the other end (red, white and yellow end) to TV input.
- Slide the **LCD ON/AV OUT** switch on the back of the unit to "AV output." The LCD will turn off and the video will switch to the TV.

Music Mode

You can change repeat mode while playing your music.

Repeat

- Press **M** until **Repeat** is highlighted.
- Press in $\blacktriangleright\text{||}$ to select between **One**, **All** or **Off** to repeat the current file or repeat all files or turn off repeat respectively.

Open WMA can be converted by the bundled video management software.

- Slide down $\blacktriangleright\text{||}$ or slide up $\blacktriangleleft\text{||}$ to select the previous and the next image.

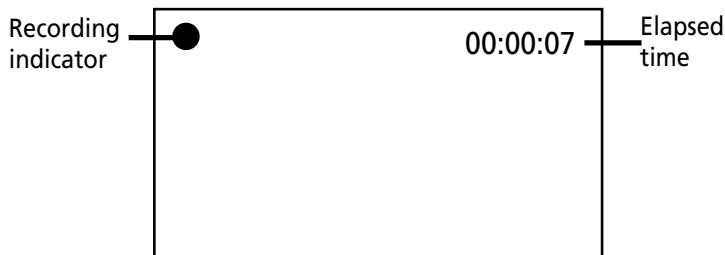

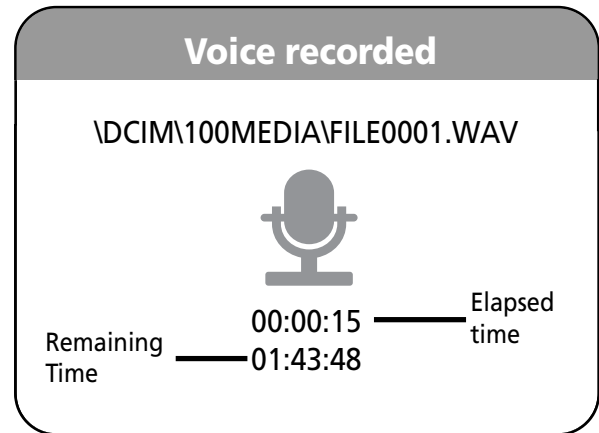
